Subject: Filing of Appeal/Stay/CO before CESTAT-Amendment in Customs,Excise, and Servic Tax(Procedures) Rules,1982 -reg.

Attention of the Importers, Trade , Customs Brokers and all the stake holder is invited to Customs,Excise, and Servic Tax(Procedures) Rules,1982 and amendment Notfn No.1 of 2020 dated 11 May,2020 issued by Hon'ble President , CESTAT,New Delhi. Important changes made in Rules ,1982 are as under :

(I)Filing of Appeal/CO(Rule 8(1): "Every Memorandum of Appeal or Cross Objection shall set forth concisely and under distinct heads, the Statement of Facts and Grounds of Appeal or Grounds of Cross Objection, as the case may be, consecutively numbered and typed in double space of the paper. They shall also contain a valid mobile number and e-mail address of both the Appellant(s) and the Respondent(s)."

II)Verification of Appeal/CO (Rule 8(4): "The verification of every Memorandum of Appeal or Cross Objection or Miscellaneous Application filed on or after the date of publication of this Notification shall state that the soft copy of the Appeal Memorandum or the Cross Objection or the Miscellaneous Application and the Documents filed therewith are the true copies of the original".

III)Soft copy of Appeal/CO(Rule 9(5): "Every Memorandum of Appeal or Cross' Objection and the documents filed along with such Appeal of Cross Objection shall

be accompanied by its soft copy stored in two pen drives."

IV) **Soft copy of paper book** (Rule 16(8): "The soft copies of the Paper Book shall also be stored in two pen drives and filed along with such Paper Book".

V) **Hearing through Video conferencing**(Rule 19(3): "Notwithstanding anything contained in Sub Rule (1) of this Rule, the President may, by a separate Notification, allow the hearing of Appeal or Cross Objection through appropriate video conferencing platform in the manner as may be notified".

VI) **Soft copy of Stay Application** (Rule 28A(5): "Every application for stay shall be accompanied by three. copies of the relevant orders of the authorities of the department concerned, including the appellate orders, if any, against which the appeal is filed to the Tribunal by the Appellant and other documents, if any. The soft copies of the stay application, the relevant orders and the documents. shall also be stored in two pen drives and filed along with such application".

2) All the the Importers, Trade , Customs Brokers and all the stake holder to note the above developments . They are requested to take note and publicize the contents of this Public Notice among their members/constituents.
