Subject: Customs Authority for Advance Rulings (CAAR) Regulations 2021 – regarding.

Attention of all Importers, Exporters, Custom Brokers, concerned departments and all other stakeholders is invited to Board Notification No. 01/2021 – Customs (N.T.) dated 04.01.2021 issued vide F. No. 275/16/2018-CX.8A (Pt.) wherein the Customs Authority for Advance Rulings (CAAR) Regulation, 2021 have been notified

2. Further pursuant to the amendment in Customs Act, 1962 vide Finance Act, 2018, relating to creation of new Authority viz. Customs Authority for Advance Rulings (CAAR), two authorities viz. CAAR, Delhi and CAAR, Mumbai have been notified vide Notification No. 102/2020-Customs (N.T.) dated 23.10.2020 read with Notification No. 116/2020-Customs (N.T.) dated 31.12.2020 with effect from 04.01.2021. 3. An application for obtaining an advance ruling shall be made in Form CAAR-1 before the jurisdictional authority as per the jurisdiction specified in column (3) of the Table below:-

4. The jurisdiction shall be determined in terms of the address provided by the applicant while making the application, and the Authority for an applicant providing an address other than that of within the territory of India, shall be the Authority situated at Delhi.
