Subject: Waiver of Late fees on account of system down for Budget Update - reg

Attention of all Importer/Exporter, Customs Brokers, CFSs, Custodians, General Trade under the jurisdiction of Mumbai Customs Zone – III, all other stakeholders and all the taxpayers is invited to ICES Advisory No. 05/2021 dated 28.01.2021 regarding Budget Updation 2021-2022. As per this advisory, System was available only after suitable updation to be made in ICES according to the Budgetary changes. It is observed that some importers could not file the Bills of Entry for the consignments in the aircraft granted entry inwards on 01.02.2021 and 02.02.2021 due to shutdown of ICES for budget updation.

2. In view of the above, "late fees" imposable in terms of Bill of Entry (Forms) Amendment Regulations, 2017 vide notification No. 27/2017-Customs (N.T.) dated 31.03.2017 is hereby waived off in respect of Bills of Entry, filed belatedly, which pertains to IGMs filed on 01.02.2021, 02.02.2021 & 03.02.2021. The ICES has been restored after updations and services of Bills of Entry was enabled at 11:30 P.M. on 03.02.2021.

Difficulties faced, if any, may be brought to the notice of Additional Commissioner of Customs (Import), ACC, Mumbai, for necessary action.
