PENSION ADALAT- 2020

Pensioners/Family Pensioners having grievances relating to Pension and other retirement related benefits covered under CCS(Pension) Rules, 1972, of (1) Non-receipt of Pension /Family Pension, (2) Less payment of Pension/Family Pension, (3) Revision of Pension / Family Pension, (4) Non-transfer of pension by the Disbursing Agencies may submit their application in the prescribed format (Annexure A) on or before 19.12.2020 for redressal of grievances in the Pension Adalat to be held on 22.12.2020 at 3.00 p. m. through Video Conferencing.

2. Following types of grievances / cases shall not be entertained in the Pension Adalat :

- (i) Cases involving purely legal point e.g. Succession etc.
- (ii) Grievances involving Policy matters
- (iii) Issues like appointment on compassionate ground
- (iv) Retention of quarters after retirement and Recovery of Penal / damage rent relating thereto
- (v) Any other issue not found lying within the domain of Pension Adalat in terms of Office Memorandum dated 25.03.2011 of DOPPW (F. No. 44013/2/2010-Coord.)

3. Only those grievances are to be taken up which fall within the extant Pension Policy/guidelines.

4. The officers, who retired from Mumbai Customs Zone III may send their application / grievances in the prescribed format to this office email address - apb.zone3@gmail.com.

5. Format of application may be downloaded from the official website of Mumbai Customs Zone III - <https://www.accmumbai.gov.in>.

6. Any application/grievances received after 19.12.2020 shall not be considered for redressal in the Pension Adalat.


